**QUARTERLY UPDATE PURSUANT TO RULE 1313(2)  
OF THE SGX-ST LISTING MANUAL**

Interra Resources Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) has been placed on the watch-list by the Singapore Exchange Securities Trading Limited (“**SGX-ST**”) with effect from 5 December 2017. The SGX-ST had on 5 December 2022 confirmed that it has no objection to the Company’s application for an extension of time to 4 December 2023 to satisfy the requirements for its removal from the watch-list.

Pursuant to Rule 1313(2) of the SGX-ST Listing Manual, the Board of Directors of the Company wishes to provide an update in respect of the quarter ended 30 June 2023.

The Company will continue to make efforts and consider various options to meet the requirements of Rule 1314 of the SGX-ST Listing Manual for its removal from the watch-list by 4 December 2023, and will update shareholders on any material developments and make such necessary announcements as and when appropriate.
