CESSATION OF DIRECTORS, APPOINTMENT OF INDEPENDENT DIRECTOR, REDESIGNATION FROM NON-EXECUTIVE DIRECTOR TO NON-EXECUTIVE CHAIRMAN, AND CHANGES IN COMPOSITION OF THE BOARD OF DIRECTORS AND BOARD COMMITTEES

The Board of Directors (the "**Board**") of Interra Resources Limited (the "**Company**") wishes to announce that with effect from 28 August 2023:

- (i) Mr. Edwin Soeryadjaya has resigned from his position as Non-Executive Chairman of the Company, and accordingly, Ms. Lany Djuwita Wong has resigned from her position as Alternate Director to Mr. Edwin Soeryadjaya; and
- (ii) Ms. Loo Hwee Fang has resigned from her position as Independent Director and a member of the Audit Committee ("AC"), Nominating Committee ("NC") and Remuneration Committee ("RC").

The Board also wishes to announce that with effect from 28 August 2023, Mr. Loh Yu Jun (Lu Yujun) has been appointed as an Independent Director of the Company, Chairman of the NC, and a member of the AC and RC.

The Board considers Mr. Loh Yu Jun (Lu Yujun) to be independent for the purposes of Rule 704(8) of the Listing Manual of the Singapore Exchange Securities Trading Limited (the "**Listing Manual**").

The Board also wishes to announce that with effect from 28 August 2023:

- (i) Mr. Ng Soon Kai has been redesignated from Non-Executive Director to Non-Executive Chairman of the Company;
- (ii) Dr. Khoo Chun Leng William @Chiu Chun Nun has been appointed as a member of the AC and redesignated from Chairman of the NC to a member of the NC; and
- (iii) Mr. Ng Soon Kai has been appointed as a member of the NC and has stepped down as a member of the AC.

The Board considers Dr. Khoo Chun Leng William @Chiu Chun Nun to be independent for the purposes of Rule 704(8) of the Listing Manual.
